- ▶ Only CWS Council Members may nominate and elect Members to the Board of Directors from the active Council Members.
- ▶ The Board of Directors Consists of 11 Elected Council Members in any year.
- ▶ The term of a Board Member is 3 years.
- ▶ A Member may be elected to the Board of Directors for 3 consecutive terms, at which time he must withdraw for a 3 year minimum before they may run for election again.
- ▶ The Officers of the Board of Directors are elected by the Board from within the Board each year.
- ▶ The Board Member elected to the Office of President may only be elected to 3 consecutive 1-year terms. They may be elected again by the Board after a 3 year hiatus.
